- a) Playing Fields Trust insurance and liability There has been a report for insurance purposes on the playing equipment in the playing fields and it has shown there are repairs that need to be done to make the play area safe. The most dangerous being the climbing frame, made from hard structure and ropes, on elf which has come off. Whilst LPC agreed to low maintenance and repairs on the play area, this is an insurance matter and has therefore been handed over to Playing Fields trust to deal with. LPC Clerk found the agreement made between the Playing Fields Trust and LPC, dated 04.01.2016
- b) VAS update LPC have bought a VAS (digital speed sign) which has been installed on the boundary of the Playing Fields by a few members of the Parish Council (many thanks to them) in an attempt to slow down the traffic travelling through the village. This sign gives us a digital reading of the speeds people are travelling.
- c) Village News extra printing and delivering to keep people updated LPC support the Loddiswell Village News, however feel during the COVID - 19 restrictions are in pace, it is better not to be hand delivering extra copies and newsletter to residents. Updates are being put onto the Loddiswell 'Whats on' facebook site so please share these with people who are not PC literate.
- d) Community Payback workers The Clerk met with the organiser of Community Service workers and has established that there is some work that could be done in the village, such as painting, sweeping and tidying. Suggestions are painting the public toilets, the football shelter and tidying up the area in the car park. However, for the time being, due to the COVID - 19 restrictions, this work will be on hold. Clerk to fill in the forms sent and return.
- e) Lengths taken to help with the coronavirus information A voluntary list has been drawn up and posted on the local facebook page, one id displayed in the cabinet at the old post office and another in the shop. People have been encouraged to help their neighbours and family, s long as it is safe to do so. Many many people have come forward to add their names as people who can help and LPC thank them for their community spirit and kindness. Updates are posted on the local facebook page, as this is the safest way possible.
