2504 VAS Data Report - Cllr Matt Cross

- 72,195 movements through Loddiswell in October.
- Down significantly from previous 3 months usual trend for October
- September 82.487
- August 93,321
- July 91,365
- Reduction in traffic flow similar to previous Octobers (though still lower)
- Average speed 23.8 (outgoing) and 23.2 (incoming) consistent with previous months
- Highest speed 54mph (outgoing) and 49mph (incoming) similar to last month

- I contributed to a meeting at Aveton Gifford and Buckland tout Saints on Parish Emergency planning
- I was a delegate at the Energy Assembly organised by Sustainable South Hams and funded by SHDC

2506 District Cllr report - Lee Bonham

- The application Ref 1346/25/FUL for 11 houses near Elmwood Park on the Old school field has been withdrawn
- There has been an application for certificate of lawfulness for land for stationing of caravans at
- Primrose Meadow, Blackdown, ref 2835/25/CLE.
- South Hams Council, together with Devon's other 7 district councils plans to respond to governments
 request to reorganise local government in the county. The optimum model for reshaping Devon's local
 authorities is called 4;5;1 South Hams will join with West Devon, Teignbridge, and Torbay to give a new
 Unitary council with 425,000 residents
- SHDC believes this plan is the most effective and financially sustainable model, delivering better
 public services, while ensuring decisions are made closer to residents and reflect local needs. We
 want to thank people who took part in the surveys and engagement meetings. There will be more
 consultation at the next stages.
- Local Government reorganisation includes proposal for new local hubs or area committees. Cllr Louise Wainwright at DCC has organised a meeting on Saturday the 29th November (10.00 am to
- 1.00pm) for all local Parish Councils to discuss the proposed Neighbourhood Area Committees As a follow-up to the recent Energy Assembly, SHDC is supporting an online event, Dealing with Energy and Net zero myths and Misinformation at 7.30pm on 27th November.
- SHDC is working to make sure residents have safe, good quality homes and recently helped improve 46 properties across the District. We have now launched the Warmer Homes Grant a three-year scheme to improve up to 80 more homes, tackling cold, damp and energy efficiency. The scheme will open in early 2026
- · SHDC is working on new ideas for a Nature Festival across the district; more details will follow

2509 Sustainability - Cllr Haskins

• Councillor Paul Harvey (Chair) and I attended the South Hams Energy Assembly on Saturday, 18th October at Kingsbridge Community College. It was attended by more than 80 people to discuss everything from renewable energy and community-owned projects to retrofit and fuel poverty.

We met South Dartmoor Community Energy, a not-for-profit community energy organisation who provide free and impartial advice from making your home more energy efficient to helping people who are having problems with energy companies/bills/meters.

They are happy to come to Loddiswell to give free energy advice and support.

It was agreed for Cllr Haskins to organise an evening for Parishioners, where SDCE could present advice/guidance on energy issues. Date and plans for the event to be announced at the next meeting

 WAL are planning seeding and bulb planting on the recycling area banks and The Well on 8th and 15th November and are liaising with Richard Barney

2512 Items for discussion and decision making

A) Budget for 2026/2027 - plans for spending to discuss

- There has been a large overspend due to the resurfacing of the car park
- There has been a pay increase for the Clerk
- There has been an increase in the maintenance hourly charges
- Items to be included in the budget (for consideration only): New Loddiswell village sign, new apparatus for the play park, new barrier for the car park, move for the VAS sign, repeated funding for items such as temporary disabled toilet for the Annual Loddiswell Show and printing for the Loddiswell Magazine etc
- £500 to help bring House Martins back to the village estimate includes installation of nest boxes
- B) How do LPC feel about paying for '20 is plenty" following from conversation in the MOP section of last month meeting cost £5,000 £10,000

- Clerk contacted Highways to ask for a realistic price for this to be implemented. The reply was in considerable excess of £20,000
- VAS machines are proving to be valuable in slowing traffic and the average speed through the village is under 24mph
- Will research moving the VAS by the narrows back towards Elmwood to help slow the traffic leaving the village after the pub
- C) Update on the sink hole at Little Gate/Butter Well
- The sink hole has been filled, however there are springs which will keep causing more damage.
- · Clerk to write to contact Darts resurfacing for a quote to re pipe Butterwell
- D) First meeting of 2026 will be on January 6th
- E) Defibrilator guardian for California Cross Clerk applied for a defibrillator through British Heart Foundation for one to be installed in the adopted BT kiosk at Cali Cross
- If Loddiswell are awarded a defibrillator through the BHF, Cllr Pittman has agreed to check it every 2 weeks and report back when new pads are needed
- F) Village sign research results
- · This will be added to 2026 budget
- Cost for the sign would be around £550, mounts a further £150 and professional fitting by someone with a Section 8 qualification would cost around £700
- Clerk writing to AONB for their assistance in the matter
- G) Hedge cutting around the old School field owned by DCC update
- The site has been visited and areas that needed attending to have been cut back
- H) Oakwood Park overgrown hedge complaints passed to Highways requested a letter from Highways to be delivered to the owner
- · Response from Highways:

"definition of 'defective' - hedges near a footway are a defect where they obstruct the clear passage of users, forcing pedestrians into a road or otherwise preventing them using a path safely".

"It's not a defect and we won't take any further action"

- I) Request to paint the barrier in the car park please
- · Cllr Hine to obtain a quote for a different material that won't keep rusting. Possibility for next years budget
