2517 VAS Data Report - Cllr Matt Cross

Cllr Cross did not attend the meeting and no report was sent in, due to technical issues

2518 County Cllr report - Louise Wainwright

• Cllr Wainwright did not attend the meeting, nor send a report. However Cllr Harvey attended a meeting with Cllr Wainwright at the weekend and has written this report:

Report from meeting of 29/11/25 -Local government reorganisation [LGR] proposals.

Around 30 town and parish councillors gathered at Cliff House Salcombe

for this meeting arranged by Salcombe division County Cllr, Louise Wainwright . Loddiswell was one of 9 towns and parishes represented out of a possible 16 in the division.

Leading the presentation was DCC lead on LGR, Cllr Paul Arnott. We went through possible scenarios but at this stage, there are more questions than answers. What we do know is there will be change but what this will look like is still unknown as the government need to decide on which one of the 4 models of reorganisation will be adopted that have been submitted by DCC, District councils, Plymouth unitary and Exeter unitary.

There is a timeline to all of this with summer 2026 when the government decides. Overall implementation of the LGR is predicted to be 2029 so it will entail many more meetings yet! The impact on parish and town councils could mean more responsibilities for services at a local level and neighbouring councils working closer together to facilitate this.

There is likely to be the formation of 15 Neighbourhood Area Committees (NAC] throughout Devon. This would mean 25 parishes in each NAC so representation will be a challenge as there could be 250 Cllrs on each committee!

The next step is for us to have another joint meeting and inviting delegates from Cornwall to attend. The reason being that they already have NAC's working successfully so to learn from their experience on best way to proceed when the time comes. This will be in January and open to Cllrs only and not an open meeting involving public. Public consultation is probably 18 months away.

So, a huge upheaval to how democracy works in Devon with the demise of DCC as we know it and district councils replaced by NACs. How public services will be delivered remains to be seen.

2519 District Cllr report - Lee Bonham

• South Hams District Council has replied to the Government's request with a proposal for Local Government Reorganisation. SHDC and Devon's other district councils sent in a common plan to reshape Devon's local authorities into three unitary authorities; one in Southern Devon, one in the North with Exeter and one in Plymouth. The South Devon Unitary would cover South Hams, West Devon, Teignbridge, and Torbay.

SHDC and the other districts believes this is the best plan for the county. It will deliver financial strength and efficinches together with a good level of democratic representation so that decision making is kept close to communities

The Government will consider this plan, together with alternative options submitted by Devon CC, Plymouth, Torbay and Exeter, and make a decision on the way forward in the Summer LGR does not propose a change in the power of Parish Councils. However, there might be local committees, if the new authority decides to implement this idea

- Planning application 2063/25/FUL for change of use from a builder's yard to Class B8 open air storage near Loddiswell Butts will be considered by the SHDC Planning Committee on 11th December
- Planning application 2712/25/FUL for barn conversion to a dwelling at Clarks Barn, Loddiswell will be considered by the SHDC Planning Committee on 11th December

As I sit on the Planning Committee I am required to keep an open mind on these applications.

 would have the necessary equipment and qualifications to clear blocked drains etc. Clerk to write to

 needs.

2524 Planning

- No planning this month, however Cllr Bonham made LPC aware of the site visits taking place for the following applications, which have now been taken off public consultation:
- 2712/25/FUL Barn at 717 487 (Clarks Farm), Loddiswell
- 2063/25/FUL Land at SX 719 490, Loddiswell

2525 Items for discussion and decision making

- A) 20 is plenty school children to design a poster, LPC to judge The children will be designing a new '20 is Plenty' sign for the village and LPC will attend the school to pick a winner. The signs will be placed around the village to encourage people to slow down and drive more carefully in built up areas
- B) Paying for the village Christmas tree Unanimous decision to, once again, pay for the village Christmas tree. Thanks to the organisers and we hope the 'lighting up Loddiswell' evening went well
- C) Update on the sink hole at Littlegate/Butter Well Quote from Darts Surfacing £3,386 Darts surfacing have dug out Butterwell and cleared the pipe work and LPC have decided to appoint them to reinstated which should stop the build up of water at the well. However the collection of water and 'springs' down at Littlegate are on private property and therefore not PC responsibility
- D) Number 3, The Bank garden wall debris falling onto the footpath. What to do? Clerk to contact DCC legal department for advice on the matter. The property owner has been contacted several times to try and get the debris that is falling onto the path, cleared, but more recently there has been no response. LPC are concerned that this could be a danger for people using the path
- E) Defibrilator purchase British Heart Foundation can no longer supply one is there a need? £1200 estimate. Clerk to write to the pub and the petrol station to see if they would be happy to house and contribute towards a defibrillator on their property
- F) Website discussion ready for launch in January 2026 Clerk is discussing changes with the web designers. All photos of the councillors have now been sent in and awaits the neighbourhood plan introduction. Wils About Loddiswell have kindly sent in some super photographs for the website and Cllr Rippin has agreed to help with the NP page. Hopefully the new website will be launched in January Watch this space for the new web address
- G) Final budget figures the budget will be added to the new website. Precept last year was not increased so Clerk has advised a significant increase this year and added on a lump sum of £40,000, should LPFVHT agree to help with funding a new play park
