1704 County Cllr report - Rufus Gilbert

Cllr Gilbert has been in discussion with Highways and there are concerns over the wigwags and LPC proposal of having a Visual Aid Sign in the same place - up by the primary school. Highways is finally in support of having a speed test done in the near future to assess whether a VAS would be beneficial for the safety of the village. Cllr Gilbert will also mention the need for resurfacing to de done throughout the village, particularly Village Cross Road, Towns Lane and Ashwood Park and a bigger, more legible sign for the articulated lorries still coming through California Cross, to turn around BEFORE reaching Loddiswell. Cllr Gilbert has offered to pay for these signs also.

3432/18/FUL - Support (Martin Widger declared an interest so did not have a vote) **4043/18/FUL - Support -** however it was requested that a restriction/covenant is put in place to make the consent is personal to the current owners only, and not to be carried forward.

1709 AOB

- a) Budget LPC intentions this year are to install more lighting in the village. Plans are taking place to have lighting in the car park and along the footpath up by the playing fields. Mike Hine to speak to Andy Keen.
- b) Precept LPC voted to increase the Precept by 10% for 2019/2020 as the maintenance spending has more than doubled in the last year and LPC have plans for a safer village. A proposed 3% increase which was supported by 2 other Cllrs, but the vote was in favour of a 10% increase.
- c) Mr and Mrs Hudson have very kindly purchased a new tree for the village and will be planting it on the Courtledge Green where the old Cherry tree used to be. LPC are most grateful for such a thoughtful gesture and hope that everyone will enjoy watching it grow.

1710 Added at the Chairs discretion:

New finger posts were put in place at Rake Corner, only to be lost again with the bad weather we have had. Clerk to get in touch with Highways about replacing these, although LPC have been warned there could be a 6 month waiting list.

Clerk to get in touch with Bloor Homes regarding the blocked off exit around the back of Hams Butts, which runs along side the Bloor Homes estate.
